




Fiscal Outlook - Operating Balance


Operating balance excluding gains and losses








Indicative Liquidity Buffer


RBNZ's Holdings Under LSAP Programme



■ Expected LSAP portfolio of NZ government bonds



Current NZGB Portfolio









Secondary Market Turnover Data - Last 3 Years




